

## **Application Guidelines for Japanese Government (MONBUKAGAKUSHO) Scholarship for 2025**

### **Special Admissions for Research Students for Master's Course & Doctoral Course**

Akita University Graduate School of Science and Engineering has been newly selected for the Ministry of Education, Culture, Sports, Science and Technology (MEXT) Special Priority Placement Program for Japanese Government Scholarship Students.

This program will develop an existing program and launch the "International Program for Green Science Technology" in October 2025, a cross-disciplinary educational program that teaches environmentally conscious design with a focus on decarbonization and green energy. The program is aimed at international students, mainly from Southeast Asia and Southwest Asia, and aims to nurture future leaders with environmental science knowledge and advanced expertise who will play leading roles in their countries and industries.

#### **1. Target Students**

Outstanding students coming from overseas to study abroad and outstanding students already residing in Japan

- 2 students entering our master's program.
- 2 students entering our doctoral program.

#### **2. Nationality**

As shown in hereinafter “17. Nationality”

#### **3. Age: Applicants must have been born after April 2<sup>nd</sup>, 1990**

#### **4. Academic Background**

Those who are eligible to enter a doctoral course (first term) or doctoral course (second term) at a Japanese graduate school (including those who are certain to meet this requirement at the time of enrollment)

#### **5. Academic Grades**

It is expected for currently working adults to have GPA (Grade Point Average: 1-3 scale/ calculation method is shown in hereinafter “18. Calculation Method of GPA”) score at 2.30 or more on their final academic backgrounds, or for current students to have GPA score at 2.30 or more on their latest academic grades. At the same time, applicants shall be requested to maintain the score even during the scholarship period.

## 6. Language Requirements

Applicants shall meet either one of the following requirements about the language skill (Japanese or English).

- Japanese: Applicants shall pass the Japanese Language Proficiency Test (JLPT) level N2 or higher, or have completed an educational program in which Japanese is the primary language that meets the requirements for admission to the Master's Degree.
- English: Applicants shall have a score of B2 or higher on the Common European Framework of Reference for Languages (CEFR) in English, or have completed an educational program in which English is the primary language that meets the requirements for admission to the Master's Degree.

## 7. Arrival Date in Japan

In principle, applicants must be able to arrive in Japan during the period designated by the accepting university, which is within two weeks either side of the first day of each semester in the same year (October).

## 8. Visa Requirements

Applicants shall, in principle, newly obtain a “Student” Visa at Japanese diplomatic mission located in each country of nationality before leaving for Japan, and enter Japan with the residence status of “Student”.

## 9. Exclusions:

The following applicants are not eligible for the scholarship. If he/ she is found out as a concerned student after being selected, he/ she must be withdrawn from the scholarship.

- ① Those who are actively involved in military service or are military civilian employees at the time of their arrival in Japan or during the period of scholarship.
- ② Those who are unable to arrive in Japan within the designated period by Akita University.
- ③ Those who were previous grantees of Japanese Government (MEXT) scholarship programs.
- ④ Those who are currently applying to another program under Japanese government (MEXT) scholarship system.
- ⑤ Those who are already enrolled in a university or other schools in Japan with a residence status of “Student”.
- ⑥ Those who are prospective to complete their study at university but unable to fulfill the requirements of academic qualification and background by the prescribed date.

- ⑦ Those who have dual nationality at the time of application and cannot prove that they have given up Japanese nationality by the time of arrival in Japan.
- ⑧ Those who are planning to be absent from graduate school for a long period due to internship, research activities and so on from the time of application.
- ⑨ Those who are not seeking a degree

10. Period of Scholarship

- Master's course : 2 years
- Doctoral course : 3 years

11. Scholarship Benefits Allowance

- Master's course : 144,000 yen per month will be supplied.
- Doctoral course : 145,000 yen per month will be supplied.

12. Traveling Costs

Only an economy-class air ticket from the international airport closest to the recipient's place of residence to an international airport in Japan will be provided.

All other travel expenses must be borne by the recipient.

However, air tickets will not be provided to applicants recommended in Japan.

1. Transportation to Japan: The recipient will be provided with funds, according to his/ her itinerary and route as designated by MEXT or Akita University, with an economy-class airplane ticket from the nearest international airport to his/ her home residence (\*) to International Airport or another that Akita University designates. Expenses such as domestic transportation from his/ her home address to the international airport, airport tax, airport usage fees, special taxes on travel, or domestic transportation within Japan (including transit expense) will NOT be covered. (\* The home country address stated in the application form is regarded as the recipient's "home residence". But if it is clear the address when the recipient arrived at Japan to be different from present address, changed address is regarded.)
2. Transportation from Japan: The recipient who returns to his/her home country within the fixed period after the expiration of his/her scholarship will be provided upon application, with an economy-class airplane ticket for travel from the nearest international airport.

Note 1: Travel insurance to and from Japan shall be paid for by the recipient.

Note 2: If a grantee continues to stay in Japan after the scholarship period has ended, he/she will not be paid travel expenses to return to the home country for

a temporary return.

Note 3: If the recipient returns to his/ her home country for his/ her personal reason or the reason based on “17. Scholarship Payment Suspension Matters” before the expiration month of his/ her scholarship, he/ she will not be paid travel expenses to return to the home country.

### 13. Admission and Tuition Fees

Admission and tuition fees will not be charged to the recipients.

(The host university will bear the cost)

### 14. Scholarship Payment Suspension Matters

The scholarship will be cancelled in principle in the following situations. If the recipient has been receiving the scholarship despite his/her falling under any of the following situations, the recipient shall be ordered to return the total/ partial amount of scholarship that he/she received during the period wherein he/she was involved with any of the following situations:

- ① The recipient is determined to have made a false statement on his/her application.
- ② When a student has violated a pledge made to the Minister of Education, Culture, Sports, Science and Technology (MEXT) .
- ③ The recipient violates any Japanese laws and is sentenced to imprisonment with or without work for life or for a period of exceeding 1 year.
- ④ The recipient is taken a disciplinary action such as expulsion, suspension and an official letter of censure officially published by the university, based on the regulations of the university.
- ⑤ It has been determined that it will be impossible for the recipient to complete the course within the standard education period because of poor academic grades, suspension or leave of absence.
- ⑥ The recipient arrives at Japan without valid student Visa, or the recipient's residence status has changed to one other than “Student”.
- ⑦ The recipient has received a scholarship from another institution (excluding those specified for research expenditures).
- ⑧ The recipient has proceeded to a higher level of education without receiving approval for an extension of the period of the scholarship.
- ⑨ The recipient has withdrawn from Akita University or has moved to another university/ college or another graduate school.
- ⑩ The recipient fails to keep GPA at 2.30 or more at each end of the academic year, or required grade level of Akita University.

#### 15. Requirements for Completion of Program

- Complete the master's course by satisfying the completion requirements for the department you are entering.
- Complete the doctoral course by satisfying the completion requirements for the department you are entering.
- Take subjects specified by us.

Compulsory subjects in the master's course are 8 credits in total, and compulsory subjects in the doctoral course are 2 credits in total.

#### 16. Calculation Method of GPA (Grade Point Average)

Applicants shall calculate their own GPA at the time of their final academic background or the current academic record at their relevant course according to the calculation method below.

Firstly, applicants shall determine "Assessment Point" based on the table shown in as follows, and then calculate by applying a formula indicated under the table.

The formula to be applied:

$\{ ("The\ number\ of\ credits\ of\ which\ "Assessment\ Point" \ is\ 3 \times 3) + ("The\ number\ of\ credits\ of\ which\ "Assessment\ Point" \ is\ 2 \times 2) + ("The\ number\ of\ credits\ of\ which\ "Assessment\ Point" \ is\ 1 \times 1) + ("The\ number\ of\ credits\ of\ which\ "Assessment\ Point" \ is\ 0 \times 0) \} / The\ total\ number\ of\ registered\ credits$

Note 1: If credit system is not used for the lectures/ classes registered, the number of credits shall be calculated with being replaced with the number of subjects.

Note 2: Assessment that is not listed in the table above shall be excluded.
